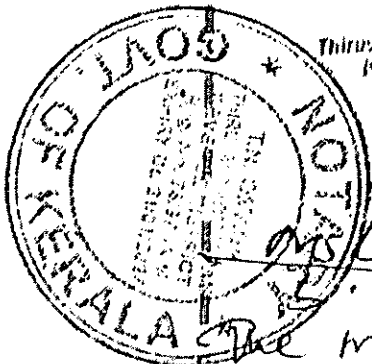
AFFIDAVIT

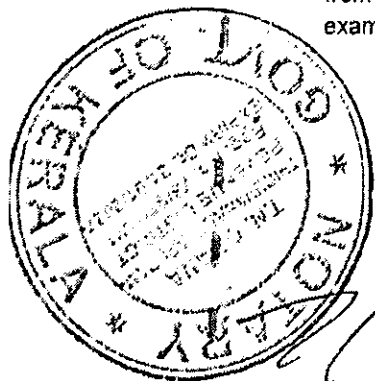


