- The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in certificate as per
- The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiable planning 4. in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas. 5.
- The school should go through the provision of Affiliation and Examination Bye Laws and keep a copy there of for reference purpose and also advised to visit CBSE websites i.e. http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates. The School is

- Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in
- Running of coaching institutionsin the school premises in the pretext of providing coaching to the students for various examinations 15. is not permitted by the Board. Strict action would be taken on defaulters.
- The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ 16.
- Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the school authorities, the school authorities are required to acquaint themselves with all the rules contained in Affiliation & Examination Bye-laws and 17. circulars/guidelines/notification issued by the Board from time to time.
